

Project-related conditions

Project conditions of On The Rock Veranstaltungskonzepte GmbH (“The Organizer”) on the platform Octorank UG (limited liability) (“The Platform”) for the Startupnight Application 2019.

Rules and procedure

The following rules and procedures apply:

- Applications can only be submitted via The Platform and only within the submission deadline, which is shown on the corresponding website of the The Platform.
- Candidates will be chosen by The Organiser based on the application material. They will be informed in advance via the submitted contact information.
- Travel and accommodation expenses can not be covered.
- The submission of application material alone does not imply any right to receive any benefits from The Platform or The Organizer. The Organizer will decide at his sole discretion about the attribution of any benefits such as free booth, matchmaking or prize money.
- If you're chosen and notified, the organiser plan to distribute a free booth, 3 exhibitor tickets and full access to the network and all parts of the Startupnight. To help us apply the finishing touches to the event, the organiser plans to ask for a deposit of 250€ which will be refunded in full if you attend or cancel in time. Cancellations after July 29 will receive a 50% refund - after August 19, the cancellation fee will be 100%.
- The following requested information might be used in public, e.g. on the website startupnight.net, on banners of the Startupnight event or on the social media channels of the Startupnight event:
 - o Part I (“Company Information”)
 - o Focus Area, Preferred Partner, Video Link

Conditions of participation

Startups with technological solutions can apply to this challenge. Applying Startups have to

- provide all required information within the application form on the Octorank platform and
- identify with one of the five mentioned focus areas.
